2012 Important Dates

- **March 18th, Entries must be postmarked no later than.**
- April 9th, Notices sent out.
- April 20th, last day to get artist bio and insurance form to The Museum.
- **April 30th, deliver artwork 9 a.m. - 1 p.m.**
- May 3rd, Opening 5:30 - 7:30
- **May 25th, Pick up artwork 9 a.m. - 12 Noon**

Deadline For Entry: March 18, 2012

Entries must be postmarked no later than Saturday March 18th

Entry Fee: \$25.00 for up to two entries. Make checks out to WACG. You **do not** have to be a WACG Member to enter this Exhibit.

Acceptable forms of art include painting, drawing, graphics, photography, mixed media, fiber, textile, sculpture, hand-crafted jewelry, and original ceramics (ceramics created from commercial molds will not be accepted).

All entries must be original and executed by the artist **within the past two years** and not previously shown at a WACG Exhibit or at the Art Museum. *Work created in a class or with the help of an instructor is not eligible.* All work must be the sole **original** creation of the artist.

Model Release: It is advised that a signed model release be obtained for work depicting the recognizable likeness of a person; however this is the sole responsibility of the artist. Neither WACG nor the Art Museum will assume any liability for work submitted without *written permission* from the model.

Photos are required for this exhibit entry. *No slides.*
Photos must be no larger than 4 x 6 inches. Larger photos will not be accepted. All 2-D artwork should be photographed before framing. All artwork should be photographed with a neutral and uncluttered background.

Take care creating these photos since entry into the exhibit is judged solely on the photographs.

Submitted work must be **exactly the same as depicted in the entry photos.** **Do not crop out parts of the images of the entry artwork, include the complete work of art.**

Photos of accepted work will be retained by WACG for use in the Juried Exhibit Display Book which will be on display during the exhibit and will also contain the bios of the exhibiting artists.

Size Limits:

2-D: Framed size must not exceed **50 inches** in either width or length, must be securely framed and must be

WIRED on the back for hanging.

Gallery wrapped canvas does not have to be framed, but must be at least 1.25" thick and all edges must be painted. Corner brackets and clip mountings will not be accepted.

3D: The finished size may not exceed **95" high and/or 72" in width or depth and must be fully equipped for hanging and/or installation (if free standing).** Sculpture weight may not exceed 100 pounds per sq. foot of base area. Artist will be totally responsible for prearranged handling of work over 50 pounds.

The Art Museum and WACG will share a 30% commission on all sales which occur during the exhibit.

Instructions For Accepted Artists

No changes or substitutions for accepted entries.

Upon acceptance of your work, you will receive a notice and a very *important form* from The Art Museum concerning insurance information. **All information on the Insurance Form must be exactly the same title, size, and price as you put on your Entry Form. Every entry must have a stated price/value for insurance purposes even if not for sale.**

Failure to return the Insurance Form to The Art Museum by 4 P.M. April 20, 2012 will result in elimination from the exhibit.

Artist Biography: Please include a short, one page **Artist Bio** and send **with the insurance form** to The Art Museum.

Complete the form, sign and return **immediately with the Bio** to:

Do not send insurance forms to WACG.

Although great care is always used when handling art work, neither WACG nor the Museum will be responsible for damage or loss of work left beyond the pick-up date and time. A \$10 per day storage/handling fee may be charged.

Prepare your Artwork for delivery to the Art Museum.

For 2-D entries the frame should be well secured and the hanging wire in place. Place your name and title of work on right upper back of entry.

For 3-D entries place your name and title of the work on the bottom or side.

All works should be clean, in good condition and ready to display.

If you cannot deliver or pick-up your artwork during the specified hours, you must make arrangements for someone else to do it for you.
